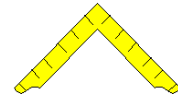

MINUTES OF STATED MEETING
October 10, 1978

There were 15 members present.

A Master Mason's Lodge was duly opened at 7:30 P.M.

The Minutes of the Stated Meeting of September 12, and the Called Meetings
of September 5 and 30 were read and approved.

The following Petitions for Degrees were received and referred to special
committees as named below.

Kent Ray Flanagan: Committee, William T. Warrick, Anthony Warrick,
and Park C. Grissom.

Ricky Lynn Hodges: Committee, Jack C. Decatur, Rodger Adams, and
Warren Hardin.

Gary Lynn Sanders: Committee, Phillip Booth, Joe Per~~4~~ and Freddie
T. Biggs.

A Petition for Affiliation by Certificate of Good Standing was received from
Norman L. Olsen and referred to a special committee of Grady Hardin, Jerry Smith,
and Thomas J. Porterfield.

The Special Committee report on the Petition of Eugene Douglass Adkins
was two favorable and one unfavorable.

A Ballot was taken and Mr. Adkins received 5 Black and 10 white, rejecting
him for three years.

A letter from the Grand Secretary was read regarding insurance, and a letter
from Judge Nathan White, Jr. was read inviting the Lodge to the cornerstone
leveling at the new courthouse.
